APPLICATION CONDITIONS

- 1. To promote equitable and fair treatment of shareholders according to the corporate governance principles, each shareholder is granted with the rights for 1 seat only (no accompanying person and no transfer of rights).
- 2. Shareholders having the right to apply are those whose names are shown in the share registration book closed on August 15, 2016 and hold not less than 100 shares.
- 3. Shareholders who are juristic persons must enclose a certified copy of the business registration document.
- 4. Any person who has ever visited Sirikit Oilfield with PTTEP (including representatives of any juristic persons) is not eligible to join this visit.
- 5. Application Form and supplement documents in no. 3 (for shareholders who are juristic persons) must be delivered to PTTEP by **September 26, 2016** (by postal mail only).
- 6. Entitled participants will be drawn, together with the waiting list, on September 27, 2016. The list of successful applicants will be announced at www.pttep.com > News & Media > News & Announcement on September 28, 2016 in the afternoon.
- 7. PTTEP will contact the successful applicants in no. 6 via the telephone number given in the Application Form within 3 working days (from the announcement date as stated in no. 6).
