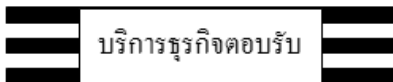

APPLICATION CONDITIONS

- Each shareholder is entitled to 1 seat (no accompanying person and no transfer of rights) and can select only 1 group.
- Shareholders having the right to apply are those whose names are shown in the share registration book closed on August 9, 2019 (Record Date) and hold not less than 100 shares.
- Shareholders who are juristic persons must enclose certified copies of the business registration document and identification card/passport of authorized director.
- Application Form and supplement documents in no. 3 (for shareholders who are juristic persons) must be delivered to PTTEP **by September 25, 2019** (by postal mail only). PTTEP will not consider any application that does not follow the above conditions, or is incomplete or unclear.
- PTTEP will contact the successful applicants via the telephone number given in the Application Form during October 1-4, 2019. If PTTEP cannot contact the successful applicants within such period, PTTEP reserves the right to cancel that application and will contact another applicant from the waiting list as a substitute.

On the travelling date, PTTEP will return a Baht 5,000 deposit in Cashier's Check to those participants who have never visited Sirikit Oilfield with PTTEP only.

If the entitled applicants have not paid the deposit/traveling expenses and delivered the voucher to PTTEP within the specified time, PTTEP will consider this as a cancellation as well.

6. **In case of any cancellation, please notify the Company before October 18, 2019.** For those who have notified PTTEP of their cancellation before October 18, 2019, The Company will return the deposit/traveling expenses at a later date, without any interest. Otherwise, if the notification is made later than the said date or the applicant does not show on the travelling date, PTTEP will not return the deposit/traveling expenses.
