APPLICATION CONDITIONS

- 1. Each shareholder is entitled to one seat (no accompanying persons and no transfers of rights). Only 1 group can be chosen.
- 2. Shareholders having the right to apply are those whose names are shown in the share registration book closed on August 16, 2023 (Record Date) and who hold not less than 100 shares.
- 3. Shareholders who are juristic persons must enclose certified copies of the business registration document and identification card/passport of an authorized director.
- 4. Qualified applicants **must not be over 70 years old as of September 15, 2023** and be in a good physical condition and able to walk unaided by any medical equipment (e.g. wheelchair, walker and cane) because there may be steep slopes or step up-down stairs which may be inconvenient for the elderly. Please specify your age in the Application Form. If the age is not specified, PTTEP reserves the right to participate in this program.
- 5. Shareholders can submit applications by post (using the envelope for returning Application Form to PTTEP) or via QR Code. For juristic persons, the supplement documents in no. 3 must also be attached and submitted to PTTEP by Friday, September 15, 2023. PTTEP reserves the right not to consider application forms that violate the conditions, or that provide incomplete or unclear information.
- 6. PTTEP will conduct a draw to select participants and substitutes on September 21, 2023. The list of qualified applicants will be announced at www.pttep.com > News & Media > News & Announcement on September 26, 2023.



7. PTTEP will contact the qualified applicants in no. 6 via the telephone number given in the Application Form within 3 working days during September 27 - 29, 2023. If PTTEP cannot contact the qualified applicants within such period, PTTEP reserves the right to cancel that application and will contact other different applicants from the waiting list as possible substitutes.

Copies of the pay-in slips and identification cards (ID)/ passports must be sent via email address Shareholders Visit@pttep.com or electronic channels specified by the company within October 11, 2023. If the qualified applicants have not paid the deposit and delivered the pay-in slips within the specified time, PTTEP will consider this is as a cancellation. On the travelling date, PTTEP will return the Baht 5,000 deposit in a Cashier's Cheque.

In case you have to cancel, please notify PTTEP by October 11, 2023. For those who have notified PTTEP of their cancellation before October 11, 2023, the Company will return the deposit/travelling expenses at a later date, without any interest. Otherwise, if the notification is made later than the said date or the qualified applicant does not show up on the travelling date without necessary reasons, PTTEP will not return the deposit/travelling expenses. PTTEP reserves the right to disqualify any future applications under this project.
